ON THE CASE CONCERNING THE DETERMINATION OF THE ISSUE REGARDING THE CONFORMITY OF THE OBLIGATIONS STIPULATED BY THE AGREEMENT ON STATE CREDIT ALLOCATED TO THE REPUBLIC OF ARMENIA SIGNED ON 20 MAY 2009 IN MOSCOW BETWEEN THE GOVERNMENT OF THE REPUBLIC OF ARMENIA AND THE GOVERNMENT OF THE RUSSIAN FEDERATION WITH THE CONSTITUTION OF THE REPUBLIC OF ARMENIA

Considering the results of the examination of the case and ruled by Article 100 (2), Parts 2 and 4 Article 102 of the Constitution, Articles 63 and 64 of the RA Law on “The Constitutional Court”, the Constitutional Court of the Republic of Armenia **DECIDES:**

1. The obligations, stipulated by the Agreement on State Credit Allocated to the Republic of Armenia signed on 20 May 2009 in Moscow between the Government of the Republic of Armenia and the Government of the Russian Federation, are in conformity with the Constitution of the Republic of Armenia.
2. Pursuant to Part 2, Article 102 of the RA Constitution this decision is final and enters into force from the date of publication.
